 - **Priority Mail.** Items 70 lbs. and under will be delivered in 2-3 days to most U.S. addresses. Rates are on this page.
 - **Truck Freight.** We use Fedex Freight Co. to ship items that weigh more than 150 lbs. or are too large to ship using UPS. A residential delivery fee will apply to shipments made to residential or rural areas.
 - **International Orders.** Ship via USPS Priority Mail International, DB Schenker or UPS International services.

Returning Merchandise
